

Call for Artists—the All-Saints Show

February has St. Valentine's Day and March has St. Patrick's Day, but there are numerous saints throughout the year—from the well-known—Anthony, Francis, Joan of Arc—to the obscure—Bertille, Pachomius and the Martyrs of Japan. Do you have a favorite saint? Know someone who is a saint—or thinks they are a saint? What happens when a saint like Christopher gets demoted to the status of legend? What is the role of a saint in a secular world?

TZ Productions is sponsoring a juried “All-Saints” Show, to be exhibited at the Barton Gallery, in Sacramento. The Barton Gallery, located at 1723 I Street, next to Michelangelos Restaurant, has been in operation over 12 years, featuring the works of established and emerging local artists (see <http://www.sacartz.com>).

The All-Saints Show will include an Artists' Reception and Second Saturday Reception. Entry fees will go toward publicity.

Entry

Artists residing in the Sacramento area are eligible to enter. Entries are limited to original artwork. Reproductions or reproductions of artwork in another medium will not be considered. All mediums are eligible, except for video, drama and jewelry.

Size Limitations

Two-dimensional works are limited to no more than 36” wide and 48” in length. Sculptures may not weigh more than 60 lbs.

Entry Procedure

Fill out entry form and mail with your check or money order made payable to TZ Productions along with an 8X10 print (photo) for each work submitted and a list of works submitted. (Three-dimensional works may have up to three photos.) Alternatively, you can submit a CD with digital images.

To Apply

Entry fee: \$20. The fee is non-refundable and entitles the artist to submit up to 3 works. Please make checks payable to TZ Productions and mail to 2201 Second Avenue, Sacramento, CA 95818.

Sales

A 40% commission will be charged on all sales. All submittals must be available for sale.

Responsibility

Every precaution will be taken in handling entries. Barton Gallery and TZ Productions assume no responsibility in case of loss or damage to submitted or accepted works. If the work is not representative of the sample photo, it may be disqualified from the show.

Receiving

Accepted works must be delivered to the gallery, ready to hang. No saw-tooth hangers.

Agreement

Sending your entry to this exhibition constitutes an agreement on the part of the entrant to all conditions set forth in this prospectus. TZ Productions reserves the right to reproduce work in the exhibit for promotional purposes.
